New Key Role Designed to Measure Efficacy of Programming

(New York, NY – November 4, 2016) – Jonathan Rose Companies, LLC, a leading green real estate development, investment and project management firm, has hired longtime nonprofit executive Lori Stanlick in the newly-created role of Director of Social Services in order to further implement the Communities of Opportunities program. In this new role, Stanlick, a licensed social worker, will leverage community resources in order to provide additional support to residents of the company’s national developments. As part of her responsibilities, Stanlick will create best practices to gather information from the Communities of Opportunities demonstration project, endeavoring to quantify the systemic economic benefits of housing-based interventions and extrapolating them in order to make the case for new funding streams, while improving resident and community outcomes.

She began her career as an art retailer at Ellen Harris Gallery in Massachusetts.

Stanlick, earned a Bachelor of Arts in Psychology from Clark University and a Master of Social Work from Columbia University. She obtained her Low Income Tax Credit Certification in 2010. Stanlick is currently a committee member for the Westchester County Continuum of Care as well as a member of the Weill Cornell / NYPH Psychiatric/Geriatric Mental Health Coalition.
