Avison Young New York arranges sale of development site in Carmel, NY

International buyer to build first distillery facility in the U.S. on 12.75-acre site in Putnam County

New York City – The New York City office of Avison Young is proud to announce that the firm has arranged the \$3.2 million sale of a 12.75-acre development site located at 39 Seminary Hill Road in Carmel, New York, part of Putnam County.

An Avison Young team comprising Arthur Mirante, Principal and Tri-State President, Martin Cottingham, Principal and Matt Pynn, Associate, arranged the sale on behalf of the buyer, Alexandrion Group, an international distiller. The seller was Hinckley Holdings, LLC & Covington Development, LLC.

The site includes a 136,000-square-foot office and warehouse facility with parking and is part of a larger 50-acre campus. The Alexandrion Group, which currently has offices in Romania, Cyprus and Brazil, is planning to build its first distillery in the U.S. on the site.

"The acquisition of this development site will prove to be a smart investment for the buyer," said **Mirante.** "Before engaging Avison Young, the Alexandrion Group had been seeking a property that would serve as its first U.S. distillery facility for quite some time. The site was the former home of Guidepost Publishing Group of the Foundation for Christian Living and at the time of the purchase, the property housed Paladin Center, a tactical training center for law enforcement and private security groups. Alexandrion Group produces Saber Elyzia liqueurs, Brâncoveanu brandy, Alexander Vodka and Gin, Kreskova vodka and Zolmyr liqueurs.
