Morgan Asset Management, announced the completion of a fully repurposed IOS build to suit development located at the Sunshine Industrial Park in Clearwater, Florida.

The venture acquired Sunshine Industrial Park in September 2022 and commenced work in May 2024 on an 18-acre build to suit project for Insurance Auto Auctions (IAA). The site will serve as IAA's primary hub for the greater Tampa Bay region.
