Unit finishes include hardwood-style vinyl plank flooring, stainless-steel appliances, granite countertops, walk-in closets, Smart TVs in unit living rooms, and a private bathroom for each bedroom. Residents enjoy shared amenities such as a clubhouse, study lounges, 24-hour fitness center, and an outdoor courtyard with grills. On-site parking is available for 68 cars.

With the addition of Eclipse on Broad, Landmark owns or operates seven student housing assets comprising over 3,000 beds in Athens, Georgia.
